Budget cuts from the state level down to the local level have impacted the shelter and the outreach and administrative staff to the point that we have had to lay off employees and implement furlough days. Even with all of these actions, we are in desperate need for monetary donations and are at a critical stage.

CAPA not only facilitates the Open Arms Shelter and office staff, but we also have Professional Development, Adolescent Pregnancy Prevention, Child Abuse and Peer Abuse in the Elementary and Middle Schools, and various Parenting Programs. This does not include the many presentations that we also conduct to various groups.

We want to stop child abuse and the cycle that is perpetuates. However, we cannot do this without the help of the community. There are many costs involved in running an organization such as ours.

During these self-correcting times, child abuse and neglect continue and more than likely, greatly increase the need for services to families. We are committed to reinventing ourselves and moving forward to ensure that children don't fall between the cracks during these trying times.

Beaufort County Child Fatalities at All Time High

2009 was a terrible year for Beaufort County's children. According to SC Dept. of Health and Environmental Control (DHEC) statistics, from 1999 to 2007 there were three child homicide victims in Beaufort County. In 2009, Beaufort had four children die in their own homes from suspected child abuse and neglect.

The human service and law enforcement providers in our county are working together to identify gaps in service and create more ways to band together to protect children. Engaged in this process are over 30 members of the 14th Judicial Circuit Multi-Disciplinary Treatment Team.

We can do better...when a child dies at the hand of a caregiver, while we are outraged, we must all take responsibility for changing a system that is stretched too thin.

The walk, a long-time goal, involved over 150 people who walked, ran, pushed strollers, wheel chairs and walkers, pulled wagons loaded with happy children along a route in downtown Beaufort. The event culminated in the park with a celebra-

tion honoring many wonderful people who have touched the lives of our residents. On April 24, 2010, we will once again fill streets with participants in the 2010 Angel Walk.

CAPA's Open Arms Shelter will celebrate its 25th Anniversary on March 28th. We hope to celebrate this momentous event at the Angel Walk and with shelter tours throughout the year. Former residents are encouraged to contact us to share their memories of the shelter and to help us celebrate.

CAPA weathered many budget cuts throughout 2009, keeping our course

steady in supporting Beaufort's children and their caregivers. It has been somewhat of a rocky ride. Staff members are currently being furloughed one day every pay period in an effort to maintain services.

We are currently facing one of the toughest times in CAPA's nearly 30 year history. With the support of our donors, volunteers, board members and partners, we are committed and ready to help our community get through these tough times.

CAPA Outreach Programs

In FY2006-7, there were 380 investigations into reported cases of abuse and neglect involving children. DSS determined that 235 children were victims of abuse or neglect, constituting 0.7% of children in Beaufort County. (KidsCount)

CAPA provides parent education, parent support and numerous school and community-based education classes for both adults and for children ages 6 to 18. These programs deal with a variety of topics ranging from peer abuse (bullying) to child abuse and neglect and are coordinated by Jessie Chapman.

CAPA also offers programs targeted at breaking the cycle of teen pregnancy. Working with the faith community and other youth-serving organizations, our staff delivers best practice, science-based curricula.

CAPA could not function without the services donated to our organization. Volunteers very modestly recorded 10,000 hours of donated time in 2009. Conservatively speaking, the cash value of that time is nearly \$120,000!

Shelter Update

The Open Arms Shelter continued to be a busy place as we cared for 56 children for 2,627 days of care in 2009 (an increase of 355 days of care over 2008). We also increased our average daily attendance from 6 children to 7.2 per day. Although we experienced an increase in overall days of care during 2009, in the last quarter we saw a significant decrease in referrals and placements at the shelter.

The current economy's impact is a significant issue for human service agencies, including the S.C. Dept. of Social Services, who is our referral base. DSS also is in the process of implementing a process improvement plan to address issues identified in a 2009 Federal audit. This has resulted in a reduction in the number of active cases and, whenever possible, avoids taking children into protective custody by developing a treatment plan that leaves the children in their own homes, with relatives and/or friends. This resulted in a decline in shelter placements statewide in late 2009. We also experienced a 15% decrease in our daily rate from DSS in early 2009 which resulted in a loss of \$35,100.96 in CAPA reimbursements. After a year negotiating, the daily rate has been renewed at the pre-cut amount for the next 5 years. As DSS works to protect abused and neglected children, we anticipate referrals to go back to levels previous of the last quarter of 2009.

Even in this climate of financial crisis, CAPA was blessed in 2009 to find government funds to update our facility and im-

prove services. With a grant awarded by the S.C. Dept. of Public Safety from Victim of Crimes Act (VOCA) funds, we are able once again to fund our Case Manager and Case Manager Assistant positions, repair the shelter ceilings, and purchase a much-needed washer and dryer set. Part of our contract is to provide and document follow-up services for children that have been in our care on a 30/60/90 day basis after discharge.

The shelter maintains a safe, warm and caring environment with highly trained staff who deliver quality care to the children who come into our care.

We are also in close conversation with other human services stakeholders to include Hope Haven and other members of the 14th Judicial Circuit Multi-Disciplinary Team (MDT). They offer much appreciated support, services and encouragement during this tough time.
